Cheer

Financial Update

- Would like to handle concessions as a separate account.
 - o Start with what we need for initial inventory.
 - o Allow Concessions manager to have a debit card for that account only.
 - O Set a limit to what \$'s are in that account.
 - o Setup some processes (i.e., a cash count when volunteers change shifts).
- Reimbursement form will be created.

Concessions

- We have a potential interested party for Concessions Manager.
- Need to make sure we have a support structure for that person.

Key's

Scholarship Program

- Verbaige to include in the contract:

 - o If they miss a scheduled volunteer time, they must re-schedule. If they miss 2, they will be suspended.
- Send draft contract prior to next meeting for review.

Marketing

- Keep in mind USA Cert and CPR costs
- Option proposed: Everyone pays for their kid, the league pays for the USA football cert, and League schedules a CPR training that is paid for.
- Recommend removing Team Manager Discount approved by all.
- Reimburse USA Cert and CPR once class has been taken.

Bi-Laws

• We are amending the by-laws to include placing the YMCA on our insurance provider. We have a couple teams that want to play spring football. This will allow us to use our own equipment, which is better than the equipment they would provide.

Equipment

 We will be putting out helmets on a 3 year replacement program based on previous meeting discussions. This will allow us to keep up on current helmet technology and provide good quality equipment to our players.
